TDS 2% Under Section 194G shall be deducted on Sellers & Sub-Stockists Prize Amount w.e.f. 1st October, 2024.

However, the stockists/sub-stockists/sellers/retailers who have obtained lower deduction certificates shall continue to deduct TDS at the rate mentioned in their certificate(s).
